4. What output will I receive?

- **Review Option:** A **Microsoft Word document** with detailed, section-by-section feedback.
- **Score Option:** A **scoring sheet** based on official FETP checklists and criteria.

All outputs are delivered directly to your **email inbox**.

5. How fast will I receive the feedback or score?

Usually **within minutes**, depending on the size and complexity of the report.

6. Do I need to write any prompts?

If you receive:

10. Can the application review or score deliverables in languages other than English?

Not yet.
